USAP is a federally designated Patient Safety Organization that analyzes data from more than 2.4 million cases across more than 700 inpatient and outpatient facilities annually.

Our Clinical Operations Committee (COC), CRNA Advisory Council (CAC), and our national and local quality committees are focused on clinical quality and reflect USAP's commitment to improved clinical outcomes and patient satisfaction.
